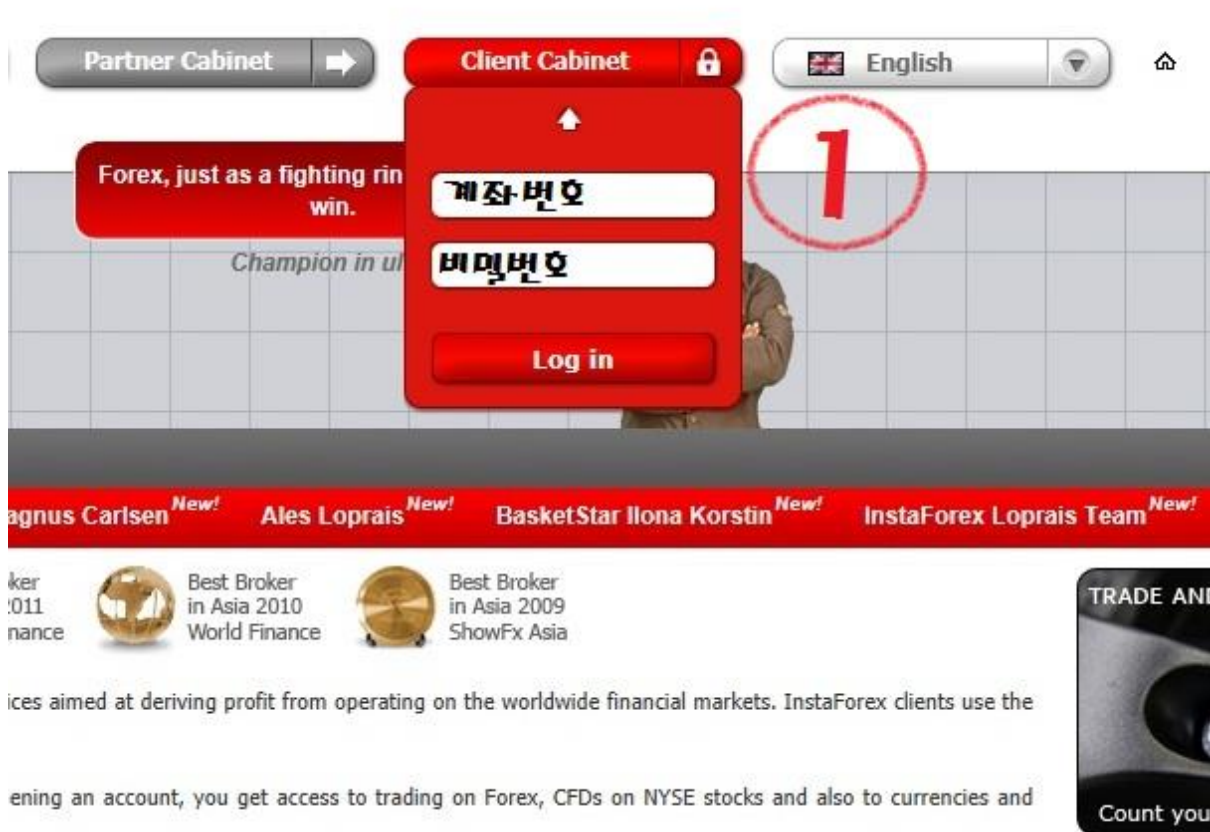


계좌서류 보내기

계좌서류를 전송하는 것은 계좌발급을 위한 의무사항은 아닙니다. 하지만, 추후 서류가 필요한 서비스 등을 등록하기 위하여 미리 전송을 하는 것을 권장합니다. **입금/거래를 함께 진행하면서 서류 전송을 할 수 있으니, 아래 설명을 잘 참조하여 주시기 바랍니다.**

1. www.instaforex.com 으로 이동을 하여, 아래 그림과 같이 [Client Cabinet](#) 에 접속을 합니다.



2. 왼쪽 메뉴탭들 중에, **“Verify Account”**를 클릭합니다.
3. “The first verification Level” 에서는 **고객님의 유효한 여권사본 (컬러)**를 업로드 합니다. 추후, 검증 절차가 마쳐진 것을 확인 후, 2단계로 넘어갑니다. 이때, **여권의 모든 정보는 계좌정보 (생년월일, 영문이름 등) 와 일치해야 합니다.**
4. 여권의 검증이 끝나면, Second Verification Level 에서 문서를 업로드 할 수 있습니다. 고객님의 주소증명 자료가 필요하오니, **거주증명 자료 (한국고객: 영문초본 사본, 영어권 고객: Driver’s License, utility bill etc.)**를 업로드 함으로 모든 절차가 완료됩니다. 이때, **서류의 주소는 계좌에 등록되어 있는 주소와 동일해야 합니다.**

Trading Account Verification

In order to take advantage of special offers of **InstaForex Company**, you have to verify your trading account. In accordance with **InstaForex** Public Offer Agreement, the trading account verification is a voluntary procedure which is not required from everyone who opens an account. If you have faced the condition of trading account verification when activating some InstaForex services, or you just want to advance the level of your trading account to a verified one, you can upload the documents on this page. During **72 working hours** the documents uploaded will be checked; either the status of your trading account will be upgraded, or additional documents will be required from you for the account verification.

There are two verification levels. Below you can see two forms to upload documents for the first and second verification levels. Before you get access to the second verification level, you need to obtain the first one.
